## Director's Report:

- --Permission to post and hire with anticipation of ESSER money with learning loss monies, 1 SW, 3 certified teachers, 1 SLP, 1 Psych (hired in June meeting).
  - --Closing grants and will bill district in July billing. All next year's IDEAs submitted.
  - -- Consolidated district plans done
- --Significant Disproportionality some districts are getting nailed on this. Children with disabilities in sub groups. Examples could be African Americans with an IEP, are they suspended more, etc.
- --ISTAR will have a new report and will be monitored through ISTAR. No indicators at this time.

- --Issues stem from over-identifying, as an example, African American males with ED. If kids stir up trouble, it doesn't mean a disability. Looking at Timeout, Seclusion, and Isolation, is there a higher ethnicity group in numbers
- --Districts will have to submit a plan in the future to reduce numbers of Timeout, Isolation, and Restraint. Improvements have been made in reporting Isolation/Timeout
- --SOPA-sites are in talks with Google to get an agreement. Make sure what you are agreeing to when teachers use in classroom
